LEGISLATIVE UPDATE

In December 2021 the NYS Fire Service Alliance met and developed a list of Legislative priorities for the 2022 Legislative session. They are:

Ambulance Cost Recovery for Fire Departments;
S7186 (Brooks)/ A534-A Jones

This bill would allow volunteer fire departments and Districts to recover the cost of providing pre-hospital EMS service from insurers, Medicare and Medicaid.

Endangering the welfare of First Responders by making illegal modifications

S.3741(Gaughran)/A.6087(Zebrowski) Would allow for legislative and administrative actions on building owners who perform modifications or conversions without obtaining the prescribed permits for single or multi-family occupancies.

Restoration of Dedicated Code Enforcement Funding

S.6970 (Kavanagh)/ A.8802 (Zebrowski) The funds in Section 54G of the State Finance Law provide state assistance to local governments for support of activities related to fire prevention and building codes. This money has been swept into the General Fund and not used for its intended purpose for 29 years.

Timely adoption of updated State Fire and Building Prevention code

S6210 (ASKoufis)/ A.3559 (A Hunter)

Would require that a new Building code as published by ICC would be adopted by the NYS Codes Council within two code cycles (6 Years)

As an added note Governor Hochul on December 31st signed the Family and Fire Prevention act. This bill bans the sale of products with toxic chemicals used as fire retardants in furniture, mattresses and electronic enclosures.

Please contact your Legislative representatives to let them know you support these bills and urge for their passage.
